

LOCHHRA EXECUTIVE SUMMARY

July 2019

- For July 2019, WV WORKS cases statewide increased to **6,435**, up **49** cases compared to June 2019's **6,386** cases.
- Adult WV WORKS cases statewide for July 2019 are **1,589**, up **58** cases compared to June 2019's **1,531** cases.
- Child-only cases statewide for July 2019 are **4,846**, down **9** cases compared to June 2019's **4,855** cases.
- Total support service payments for July 2019 totaled **\$204,280**, down **\$7,828** from June 2019's **\$212,108**.
- From December 1st, 2001 through July 31st, 2019, **3,382** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,986** customers requested an extension of benefits up to an additional 6-month period; **857** of which were approved (for a **43.2%** approval rate).

July 2019

- √ **4,846** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **101** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **107** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **6,284** Cases receiving Medicaid but not SNAP.
- √ **193** Cases receiving SNAP but adults not receiving Medicaid.
- √ **258** Adults receiving WV WORKS and are employed.
