

LOCHHRA EXECUTIVE SUMMARY

November 2019

- For November 2019, WV WORKS cases statewide decreased to **6,502**, down **19** cases compared to October 2019's **6,521** cases.
- Adult WV WORKS cases statewide for November 2019 are **1,696**, down **8** cases compared to October 2019's **1,704** cases.
- Child-only cases statewide for November 2019 are **4,806**, down **11** cases compared to October 2019's **4,817** cases.
- Total support service payments for November 2019 totaled **\$252,698**, down **\$108** from October 2019's **\$252,806**.
- From December 1st, 2001 through November 30th, 2019, **3,395** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,995** customers requested an extension of benefits up to an additional 6-month period; **859** of which were approved (for a **43.1%** approval rate).

Characteristics of the Current WV WORKS Caseload

November 2019

- √ **4,806** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.

- √ **82** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.

- √ **121** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.

- √ **6,467** Cases receiving Medicaid but not SNAP.

- √ **205** Cases receiving SNAP but adults not receiving Medicaid.

- √ **297** Adults receiving WV WORKS and are employed.
