

LOCHHRA EXECUTIVE SUMMARY

October 2018

- For October 2018, WV WORKS cases statewide increased to **6,781**, up **58** cases compared to September 2018's **6,723** cases.
- Adult WV WORKS cases statewide for October 2018 are **1,780**, up **57** cases compared to September 2018's **1,723** cases.
- Child-only cases statewide for October 2018 are **5,001**, up **1** case compared to September 2018's **5,000** cases.
- Total support service payments for October 2018 totaled **\$270,453**, up **\$20,842** from September 2018's **\$249,611**.
- From December 1st, 2001 through October 31st, 2018, **3,343** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,969** customers requested an extension of benefits up to an additional 6-month period; **847** of which were approved (for a **43.0%** approval rate).

- √ 5,001 Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ 46 Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ 115 Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ 5,919 Cases receiving Medicaid but not SNAP.
- √ 173 Cases receiving SNAP but adults not receiving Medicaid.
- √ 289 Adults receiving WV WORKS and are employed.
