

LOCHHRA EXECUTIVE SUMMARY

November 2018

- For November 2018, WV WORKS cases statewide decreased to **6,689**, down **92** cases compared to October 2018's **6,781** cases.
- Adult WV WORKS cases statewide for November 2018 are **1,700**, down **80** cases compared to October 2018's **1,780** cases.
- Child-only cases statewide for November 2018 are **4,989**, down **12** case compared to October 2018's **5,001** cases.
- Total support service payments for November 2018 totaled **\$270,030**, down **\$423** from October 2018's **\$270,453**.
- From December 1st, 2001 through November 30th, 2018, **3,350** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,969** customers requested an extension of benefits up to an additional 6-month period; **847** of which were approved (for a **43.0%** approval rate).

- √ **4,989** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **47** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **111** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **5,970** Cases receiving Medicaid but not SNAP.
- √ **176** Cases receiving SNAP but adults not receiving Medicaid.
- √ **314** Adults receiving WV WORKS and are employed.
