

LOCHHRA EXECUTIVE SUMMARY May 2015

- For May 2015, WV WORKS cases statewide decreased to **7,877** down **78** cases compared to April 2015's **7,955** cases.
- Adult WV WORKS cases statewide for May 2015 are **3,007**, down **91** cases compared to April 2015's **3,098** cases.
- Child-only cases statewide for May 2015 are **4,870** up **13** cases compared to April 2015's **4,857** cases.
- Total support service payments for May 2015 totaled **\$364,839**, down **\$15,837** from April 2015's **\$380,676**.
- From December 1st, 2001 through May 31st, 2015, **3,089** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,852** customers requested an extension of benefits up to an additional 6-month period; **786** of which were approved (for a **42.4%** approval rate).

- √ 4,870 Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ 14 Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ 109 Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ 2,549 Cases receiving Medicaid but not SNAP.
- √ 44 Cases receiving SNAP but adults not receiving Medicaid.
- √ 854 Adults receiving WV WORKS and are employed.
