

LOCHHRA EXECUTIVE SUMMARY August 2015

- For August 2015, WV WORKS cases statewide increased to **7,779** up **161** cases compared to July 2015's **7,618** cases.
- Adult WV WORKS cases statewide for August 2015 are **2,910**, up **110** cases compared to July 2015's **2,800** cases.
- Child-only cases statewide for August 2015 are **4,869**, up **51** cases compared to July 2015's **4,818** cases.
- Total support service payments for August 2015 totaled **\$324,273**, up **\$7,607** from July 2015's **\$316,666**.
- From December 1st, 2001 through August 31st, 2015, **3,112** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,867** customers requested an extension of benefits up to an additional 6-month period; **793** of which were approved (for a **42.5%** approval rate).

August 2015

- √ 4,869 Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ 53 Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ 119 Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ 2,835 Cases receiving Medicaid but not SNAP.
- √ 48 Cases receiving SNAP but adults not receiving Medicaid.
- √ 787 Adults receiving WV WORKS and are employed.
