

LOCHHRA EXECUTIVE SUMMARY

November 2015

- For November 2015, WV WORKS cases statewide decreased to **7,724** down **64** cases compared to October 2015's **7,788** cases.
- Adult WV WORKS cases statewide for November 2015 are **2,888**, down **54** cases compared to October 2015's **2,942** cases.
- Child-only cases statewide for November 2015 are **4,836**, down **10** cases compared to October 2015's **4,846** cases.
- Total support service payments for November 2015 totaled **\$368,582**, up **\$12,849** from October 2015's **\$355,733**.
- From December 1st, 2001 through November 30th, 2015, **3,134** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,881** customers requested an extension of benefits up to an additional 6-month period; **794** of which were approved (for a **42.2%** approval rate).

Characteristics of the Current WV WORKS Caseload

November 2015

- √ 4,836 Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ 64 Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ 113 Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ 3,468 Cases receiving Medicaid but not SNAP.
- √ 98 Cases receiving SNAP but adults not receiving Medicaid.
- √ 489 Adults receiving WV WORKS and are employed.
