

LOCHHRA EXECUTIVE SUMMARY

December 2015

- For December 2015, WV WORKS cases statewide decreased to **7,715**, down **9** cases compared to November 2015's **7,724** cases.
- Adult WV WORKS cases statewide for December 2015 are **2,882**, down **6** cases compared to November 2015's **2,888** cases.
- Child-only cases statewide for December 2015 are **4,833**, down **3** cases compared to November 2015's **4,836** cases.
- Total support service payments for December 2015 totaled **\$339,553**, down **\$29,029** from November 2015's **\$368,582**.
- From December 1st, 2001 through December 31st, 2015, **3,146** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,881** customers requested an extension of benefits up to an additional 6-month period; **799** of which were approved (for a **42.5%** approval rate).

- √ 4,833 Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ 13 Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ 113 Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ 3,687 Cases receiving Medicaid but not SNAP.
- √ 101 Cases receiving SNAP but adults not receiving Medicaid.
- √ 482 Adults receiving WV WORKS and are employed.
