

LOCHHRA EXECUTIVE SUMMARY February 2024

- For February 2024, WV WORKS cases statewide decreased to **4,919**, down **44** cases, compared to January 2024's **4,963** cases.
- Adult WV WORKS cases statewide for February 2024 are **1,262**, down **28** cases, compared to January 2024's **1,290** cases.
- Child-only cases statewide for February 2024 are **3,657**, down **16** cases, compared to January 2024's **3,673** cases.
- Total support service payments for February 2024 totaled **\$163,404**, down **\$8,759** from January 2024's **\$172,163**.

From December 1st, 2001, through February 29th, 2024, **3,620** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,099** customers requested an extension of benefits up to an additional 6-month period; **902** of which were approved (for a **43.0%** approval rate).
