LOCHHRA EXECUTIVE SUMMARY June 2024

- For June 2024, WV WORKS cases statewide decreased to 4,688, down 94 cases, compared to May 2024's 4,782 cases.
- Adult WV WORKS cases statewide for June 2024 are 1,234, down 22 cases, compared to May 2024's 1,256 cases.
- Child-only cases statewide for June 2024 are **3,454**, down **72** cases, compared to May 2024's **3,526** cases.
- Total support service payments for June 2024 totaled \$171,668, down \$20,721 from May 2024's \$192,389.

From December 1st, 2001, through June 30th, 2024, **3,640** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,106** customers requested an extension of benefits up to an additional 6-month period; **904** of which were approved (for a **42.9**% approval rate).
