

LOCHHRA EXECUTIVE SUMMARY May 2023

- For May 2023, WV WORKS cases statewide increased to **5,198**, up **36** cases, compared to April 2023's **5,162** cases.
- Adult WV WORKS cases statewide for May 2023 are **1,314**, up **21** cases, compared to April 2023's **1,293** cases.
- Child-only cases statewide for May 2023 are **3,884**, up **15** cases, compared to April 2023's **3,869** cases.
- Total support service payments for May 2023 totaled **\$212,573**, up **\$30,871** from April 2023's **\$181,702**.

From December 1st, 2001, through May 31st, 2023, **3,587** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,084** customers requested an extension of benefits up to an additional 6-month period; **895** of which were approved (for a **42.9%** approval rate).
