

## LOCHHRA EXECUTIVE SUMMARY June 2023

- For June 2023, WV WORKS cases statewide decreased to **5,102**, down **96** cases, compared to May 2023's **5,198** cases.
- Adult WV WORKS cases statewide for June 2023 are **1,277**, down **37** cases, compared to May 2023's **1,314** cases.
- Child-only cases statewide for June 2023 are **3,825**, down **59** cases, compared to May 2023's **3,884** cases.
- Total support service payments for June 2023 totaled **\$165,847**, down **\$46,726** from May 2023's **\$212,573**.

From December 1<sup>st</sup>, 2001, through June 30th, 2023, **3,591** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,085** customers requested an extension of benefits up to an additional 6-month period; **895** of which were approved (for a **42.9%** approval rate).
