

LOCHHRA EXECUTIVE SUMMARY July 2023

- For July 2023, WV WORKS cases statewide decreased to **5,044**, down **58** cases, compared to June 2023's **5,102** cases.
- Adult WV WORKS cases statewide for July 2023 are **1,249**, down **28** cases, compared to June 2023's **1,277** cases.
- Child-only cases statewide for July 2023 are **3,795**, down **30** cases, compared to June 2023's **3,825** cases.
- Total support service payments for July 2023 totaled **\$170,173**, up **\$4,326** from June 2023's **\$165,847**.

From December 1st, 2001, through July 31st, 2023, **3,592** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,086** customers requested an extension of benefits up to an additional 6-month period; **895** of which were approved (for a **42.9%** approval rate).
