

LOCHHRA EXECUTIVE SUMMARY

August 2023

- For August 2023, WV WORKS cases statewide increased to **5,064**, up **20** cases, compared to July 2023's **5,044** cases.
- Adult WV WORKS cases statewide for August 2023 are **1,274**, up **25** cases, compared to July 2023's **1,249** cases.
- Child-only cases statewide for August 2023 are **3,790**, down **5** cases, compared to July 2023's **3,795** cases.
- Total support service payments for August 2023 totaled **\$197,617**, up **\$27,444** from July 2023's **\$170,173**.

From December 1st, 2001, through August 31st, 2023, **3,596** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,088** customers requested an extension of benefits up to an additional 6-month period; **896** of which were approved (for a **42.9%** approval rate).
