

## LOCHHRA EXECUTIVE SUMMARY October 2023

- For October 2023, WV WORKS cases statewide increased to **5,098**, up **54** cases, compared to September 2023's **5,044** cases.
- Adult WV WORKS cases statewide for October 2023 are **1,343**, up **40** cases, compared to September 2023's **1,303** cases.
- Child-only cases statewide for October 2023 are **3,755**, up **14** cases, compared to September 2023's **3,741** cases.
- Total support service payments for October 2023 totaled **\$188,726**, up **\$24,351** from September 2023's **\$164,375**.

From December 1<sup>st</sup>, 2001, through October 31<sup>st</sup>, 2023, **3,605** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,092** customers requested an extension of benefits up to an additional 6-month period; **898** of which were approved (for a **43.0%** approval rate).
