

LOCHHRA EXECUTIVE SUMMARY

June 2025

- For June 2025, WV WORKS cases statewide decreased to **4,456**, down **150** cases, compared to May 2025's **4,606** cases.
- Adult WV WORKS cases statewide for June 2025 are **1,219**, down **85** cases, compared to May 2025's **1,304** cases.
- Child-only cases statewide for June 2025 are **3,237**, down **65** cases, compared to May 2025's **3,302** cases.
- Total support service payments for June 2025 totaled **\$167,953**, down **\$10,492** from May 2025's **\$178,445**.

From December 1st, 2001, through June 30th, 2025, **3,679** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,126** customers requested an extension of benefits up to an additional 6-month period; **913** of which were approved (for a **42.9%** approval rate).
