LOCHHRA EXECUTIVE SUMMARY July 2025

- For July 2025, WV WORKS cases statewide decreased to 4,439, down 17 cases, compared to June 2025's 4,456 cases.
- Adult WV WORKS cases statewide for July 2025 are **1,225**, up **6** cases, compared to June 2025's **1,219** cases.
- Child-only cases statewide for July 2025 are **3,214**, down **23** cases, compared to June 2025's **3,237** cases.
- Total support service payments for July 2025 totaled \$164,763, down \$3,190 from June 2025's \$167,953.

From December 1st, 2001, through July 31st, 2025, **3,683** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,127** customers requested an extension of benefits up to an additional 6-month period; **914** of which were approved (for a **43.0**% approval rate).
