LOCHHRA EXECUTIVE SUMMARY September 2025

- For September 2025, WV WORKS cases statewide increased to 4,507, up 11 cases, compared to August 2025's 4,496 cases.
- Adult WV WORKS cases statewide for September 2025 are **1,330**, up **49** cases, compared to August 2025's **1,281** cases.
- Child-only cases statewide for September 2025 are 3,177, down 38 cases, compared to August 2025's 3,215 cases.
- Total support service payments for September 2025 totaled \$187,910, up \$12,108 from August 2025's \$175,802.

From December 1st, 2001, through September 30th, 2025, **3,691** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,129** customers requested an extension of benefits up to an additional 6-month period; **916** of which were approved (for a **43.0**% approval rate).
