

LOCHHRA EXECUTIVE SUMMARY

November 2025

- For November 2025, WV WORKS cases statewide decreased to **4,321**, down **146** cases, compared to October 2025's **4,467** cases.
- Adult WV WORKS cases statewide for November 2025 are **1,208**, down **83** cases, compared to October 2025's **1,291** cases.
- Child-only cases statewide for November 2025 are **3,113**, down **63** cases, compared to October 2025's **3,176** cases.
- Total support service payments for November 2025 totaled **\$174,545** down **\$3,341** from October 2025's **\$177,886**.

From December 1st, 2001, through November 30th, 2025, **3,695** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,133** customers requested an extension of benefits up to an additional 6-month period; **919** of which were approved (for a **43.1%** approval rate).
