

LOCHHRA EXECUTIVE SUMMARY May 2026

- For May 2026, WV WORKS cases statewide decreased to **4,097**, down **35** cases, compared to April 2026's **4,132** cases.
- Adult WV WORKS cases statewide for May 2026 are **1,090**, down **11** cases, compared to April 2026's **1,101** cases.
- Child-only cases statewide for May 2026 are **3,007**, down **24** cases, compared to April 2026's **3,031** cases.
- Total support service payments for May 2026 totaled **\$129,652** up **\$17,395** from April 2026's **\$147,047**.

From December 1st, 2001, through May 31st, 2026, **3,717** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,137** customers requested an extension of benefits up to an additional 6-month period; **920** of which were approved (for a **43.1%** approval rate).
