

LOCHHRA EXECUTIVE SUMMARY

June 2026

- For June 2026, WV WORKS cases statewide decreased to **4,044**, down **53** cases, compared to May 2026's **4,097** cases.
- Adult WV WORKS cases statewide for June 2026 are **1,090** down **0** cases, compared to May 2026's **1,090** cases.
- Child-only cases statewide for June 2026 are **2,954**, down **53** cases, compared to May 2026's **3,007** cases.
- Total support service payments for June 2026 totaled **\$151,959** up **\$21,943** from May 2026's **\$129,652**.

From December 1st, 2001, through June 30th, 2026, **3,717** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,138** customers requested an extension of benefits up to an additional 6-month period; **921** of which were approved (for a **43.1%** approval rate).

60-Month TANF Limit Extension Report for June 2026:

Number of requests for extension received to date: 2,138

Number of requests approved to date: 921

Of the 921 cases approved through June 2026 for extension, 642 were for 6 months, and 279 were for periods of 1-5 months.
