

LOCHHRA EXECUTIVE SUMMARY

July 2026

- For July 2026, WV WORKS cases statewide decreased to **4,038**, down **6** cases, compared to June 2026's **4,044** cases.
- Adult WV WORKS cases statewide for July 2026 are **1,129** up **39** cases, compared to June 2026's **1,090** cases.
- Child-only cases statewide for July 2026 are **2,909**, down **45** cases, compared to June 2026's **2,954** cases.
- Total support service payments for July 2026 totaled **\$137,888** down **\$14,071** from June 2026's **\$151,959**.

From December 1st, 2001, through July 31st, 2026, **3,719** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,140** customers requested an extension of benefits up to an additional 6-month period; **921** of which were approved (for a **43.0%** approval rate).
