

LOCHHRA EXECUTIVE SUMMARY

August 2026

- For August 2026, WV WORKS cases statewide increased to **4,042**, up **4** cases, compared to July 2026's **4,038** cases.
- Adult WV WORKS cases statewide for August 2026 are **1,133** up **4** cases, compared to July 2026's **1,129** cases.
- Child-only cases statewide for August 2026 are **2,909**, down **0** cases, compared to July 2026's **2,909** cases.
- Total support service payments for August 2026 totaled **\$171,350**, up **\$33,462** from July 2026's **\$137,888**.

From December 1st, 2001, through August 31st, 2026, **3,721** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,140** customers requested an extension of benefits up to an additional 6-month period; **922** of which were approved (for a **43.1%** approval rate).
