

LOCHHRA EXECUTIVE SUMMARY

February 2021

- For February 2021, WV WORKS cases statewide increased to **5,745**, up **16** cases compared to January 2021's **5,729** cases.
- Adult WV WORKS cases statewide for February 2021 are **1,563**, up **37** cases compared to January 2021's **1,526** cases.
- Child-only cases statewide for February 2021 are **4,182**, down **21** cases compared to January 2021's **4,203** cases.
- Total support service payments for February 2021 totaled **\$78,453**, down **\$7,171** from January 2021's **\$85,624**.
- From December 1st, 2001 through February 28th, 2021, **3,464** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **2,026** customers requested an extension of benefits up to an additional 6-month period; **871** of which were approved (for a **43.0%** approval rate).

Characteristics of the Current WV WORKS Caseload

February 2021

- √ **4,182** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.

- √ **153** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.

- √ **110** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.

- √ **6,831** Cases receiving Medicaid but not SNAP.

- √ **209** Cases receiving SNAP but adults not receiving Medicaid.

- √ **87** Adults receiving WV WORKS and are employed.
