

LOCHHRA EXECUTIVE SUMMARY May 2021

- For May 2021, WV WORKS cases statewide decreased to **5,773**, down **15** cases compared to April 2021's **5,788** cases.
- Adult WV WORKS cases statewide for May 2021 are **1,521**, down **23** cases compared to April 2021's **1,544** cases.
- Child-only cases statewide for May 2021 are **4,252**, up **8** cases compared to April 2021's **4,244** cases.
- Total support service payments for May 2021 totaled **\$104,131**, up **\$8,861** from April 2021's **\$95,270**.
- From December 1st, 2001 through May 31st, 2021, **3,481** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **2,036** customers requested an extension of benefits up to an additional 6-month period; **871** of which were approved (for a **42.8%** approval rate).

Characteristics of the Current WV WORKS Caseload

May 2021

- √ 4,252 **Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.**
- √ 342 **Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.**
- √ 110 **Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.**
- √ 6,887 **Cases receiving Medicaid but not SNAP.**
- √ 216 **Cases receiving SNAP but adults not receiving Medicaid.**
- √ 115 **Adults receiving WV WORKS and are employed.**
