

LOCHHRA EXECUTIVE SUMMARY

December 2021

- For December 2021, WV WORKS cases statewide decreased to **5,560**, down **83** cases compared to November 2021's **5,643** cases.
- Adult WV WORKS cases statewide for December 2021 are **1,379**, down **46** cases compared to November 2021's **1,425** cases.
- Child-only cases statewide for December 2021 are **4,181**, down **37** cases compared to November 2021's **4,218** cases.
- Total support service payments for December 2021 totaled **\$132,815**, up **\$4,504** from November 2021's **\$128,311**.

From December 1st, 2001, through December 31st, 2021, **3,524** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,057** customers requested an extension of benefits up to an additional 6-month period; **888** of which were approved (for a **43.2%** approval rate).
