

LOCHHRA EXECUTIVE SUMMARY

January 2020

- For January 2020, WV WORKS cases statewide increased to **6,478**, up **12** cases compared to December 2019's **6,466** cases.
- Adult WV WORKS cases statewide for January 2020 are **1,685**, down **15** cases compared to December 2019's **1,700** cases.
- Child-only cases statewide for January 2020 are **4,793**, up **27** cases compared to December 2019's **4,766** cases.
- Total support service payments for January 2020 totaled **\$232,886**, down **\$33,416** from December 2019's **\$266,302**.
- From December 1st, 2001 through January 31st, 2020, **3,401** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,998** customers requested an extension of benefits up to an additional 6-month period; **859** of which were approved (for a **43.0%** approval rate).

- √ 4,793 Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ 91 Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ 123 Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ 6,596 Cases receiving Medicaid but not SNAP.
- √ 203 Cases receiving SNAP but adults not receiving Medicaid.
- √ 258 Adults receiving WV WORKS and are employed.
