

## LOCHHRA EXECUTIVE SUMMARY June 2020

- For June 2020, WV WORKS cases statewide decreased to **5,986**, down **158** cases compared to May 2020's **6,144** cases.
- Adult WV WORKS cases statewide for June 2020 are **1,506**, down **36** cases compared to May 2020's **1,542** cases.
- Child-only cases statewide for June 2020 are **4,480**, down **122** cases compared to May 2020's **4,602** cases.
- Total support service payments for June 2020 totaled **\$105,878**, up **\$12,284** from May 2020's **\$93,594**.
- From December 1<sup>st</sup>, 2001 through June 30<sup>th</sup>, 2020, **3,415** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **2,010** customers requested an extension of benefits up to an additional 6-month period; **867** of which were approved (for a **43.1%** approval rate).

**June 2020**

- √ **4,480** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **141** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **116** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **6,654** Cases receiving Medicaid but not SNAP.
- √ **201** Cases receiving SNAP but adults not receiving Medicaid.
- √ **134** Adults receiving WV WORKS and are employed.
