

LOCHHRA EXECUTIVE SUMMARY

October 2020

- For October 2020, WV WORKS cases statewide increased to **5,861**, up **23** cases compared to September 2020's **5,838** cases.
- Adult WV WORKS cases statewide for October 2020 are **1,467**, up **60** cases compared to September 2020's **1,407** cases.
- Child-only cases statewide for October 2020 are **4,394**, down **37** cases compared to September 2020's **4,431** cases.
- Total support service payments for October 2020 totaled **\$115,101**, up **\$3,960** from September 2020's **\$111,141**.
- From December 1st, 2001 through October 31st, 2020, **3,440** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **2,019** customers requested an extension of benefits up to an additional 6-month period; **870** of which were approved (for a **43.1%** approval rate).

- √ **4,394** **Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.**
- √ **138** **Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.**
- √ **109** **Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.**
- √ **6,753** **Cases receiving Medicaid but not SNAP.**
- √ **207** **Cases receiving SNAP but adults not receiving Medicaid.**
- √ **121** **Adults receiving WV WORKS and are employed.**
